My research was for a long time at the cross roads of spatial and industrial economics; It has in recent years become more multi-disciplinary and increasingly focused on questions related to territorial development processes and land use planning

Nowadays, the main topic of my research focuses on the analysis of proximity relations and on their importance in processes of territorial development. It centers on three main areas: local interactions between innovative firms and organizations; land use, urban-rural and political conflicts; local dimensions of circular economy.
